. to post-judgment security with them is but a step taken in the same direction. That purpose has been served and the rule is satisfied. There remains the requirement that the person posting the security shall have a reasonable belief of non-suitability for the purpose. The determination of whether the person has a reasonable belief of non-suitability shall be made in accordance with Rule 32. However, the determination of non-suitability or suitability for the purpose of posting judgment security is a matter of judicial discretion. See F.R.Civ.P. (Interim) Rule 65(c). We find no abuse of discretion here. Affirmed. NOTES [1] The rule reads in full: "Each of the parties shall furnish to the clerk a written undertaking to the effect that he or it will pay all costs and disbursements that may be made against him or it, in case of a default of the defendant or defendants by reason of a failure or neglect to answer or otherwise defend, and also that he or it will pay any judgment that may be taken against him or it, or the costs of such judgment, if the plaintiff fails to take such judgment. In case the judgment finally taken is for the plaintiff, such undertaking shall be filed within ten days after the filing of the plaintiff's declaration. \* \* \*" [2] The relevant part of the rule reads in full: "Unless otherwise directed by the court, the clerk shall not refuse to file any paper presented for that purpose by a party who is in poverty or destitution, provided that such party is not guilty of any fraud or imposition."
