Vera Wetherspoon appeals the final order of the Department of Health and Rehabilitative Services (HRS) terminating her Social Security disability benefits, which had been granted in 1988. We reverse. On October 11, 1988, HRS determined that Wetherspoon was entitled to social security disability benefits under section 216(i) of the Social Security Act, as amended, 42 U.S.C.A. § 416(i). The award was based on a finding that Wetherspoon was totally and permanently disabled. HRS concluded that her disability began on February 7, 1985. The date of onset was established as the 754eb5d184
