(Ibid.) 4 Defendants claim plaintiffs’ claim for injunctive relief is barred by the defense of laches because “the prescriptive period is in excess of six months”—the time to assert a laches claim—and the period began to run when the supersedeas bond was filed, when defendants mailed the notice of nonpayment of filing fees, and when the order denying the motion to vacate was entered. We agree. The six-month period for filing a claim of laches begins to run when the complaining party has notice of the facts giving rise to the cause of action. (City of Oceanside v. Superior Court (2000) 87 Cal.App.4th 1411, 1424.) “The plaintiff has knowledge of the claim and its accrual when it has reason to know of the wrong and its negligent cause, as distinguished from the act of the wrongdoer, unless the plaintiff can charge the defendant with fraud or concealment.” (Id. at p. 1425.) In the case at hand, defendants gave plaintiffs notice of their proposed actions and undertook acts that deprived plaintiffs of their rights
