the present case. Defendant had additional time to obtain and prepare transcripts, the absence of which requires a presumption of prejudice. (People v. Jones (2011) 51 Cal.4th 346, 356.) In some instances, the failure to comply with section 1237 may mean the remedy of an adequate review on appeal is unavailable. (§ 1237.5.) Moreover, reversal is not required where the record shows that defendant or his trial counsel was guilty of laches or of the conduct of an ordinary prudent person in answering the interrogatories. (People v. Gutierrez (1986) 178 Cal.App.3d 682, 689, overruled on other grounds in People v. Kane (1989) 213 Cal.App.3d 633, 636, 637; People v. Valdez (2012) 55 Cal.4th 82, 144, 166.) There is no evidence defendant was dilatory in objecting to the interrogatory or that defendant's trial counsel was dilatory in his responses. Defendant was present at trial and could have moved for a continuance or objected during trial.
