("NYSE, Inc.") are also defendants. This court has jurisdiction of this case by virtue of 15 U.S.C. § 78aa, 28 U.S.C. § 1331, and 28 U.S.C. § 1332. Plaintiff asserts the following counts of the complaint: (1) negligence; (2) breach of fiduciary duty; (3) breach of contract; (4) violation of the Racketeer Influenced and Corrupt Organizations Act ("RICO"), 18 U.S.C. § 1961 et seq.; and (5) common law fraud.
