Currently, a synthetic resin surface, a metallic surface, or a laminated article formed by bonding two or more members has been utilized in various fields including automotive and electronic fields. When the shade is in the closed state, the shade head is attached to the top of the roll-up shade. The rolling shaft is a rod with one end rolled up and the other end fixed to the shade head. The rolling shaft receives the winding wire or chain for winding and unwinding the roll-up shade. The winding wire is fed out to the other end of

the rolling shaft. When the shade is not in use, the pull tab is swung to a position under the shade head, and then the handle of the pull tab is pulled to
